

PRIVACY AND COOKIE POLICY



This is the Privacy and Cookie Policy of the website www.coronalegal.nl. Corona Legal secures your personal data through various technical and organizational measures, such as firewalls, secured servers, and data processing agreements with third parties hosting our website.
